# STRICT COVID RULES and REGULATIONS

**FOR SHOWDAY - 24 JULY 2021**

Agricultural shows joined the list of government permitted events many weeks ago at Stage 2 of Lockdown. The SWSHS committee decided to go ahead in organising the ANNUAL SHIRE and MINIATURE HORSE SHOW for 2021 while complying with all the latest recommendations in the updated Welsh Government Rules and Regulations (dated 10 June 2021) – **Keep Wales Safe: creating COVID safe events**, and ensuring our event will be SAFE and SECURE, with the following actions securely in place

The SWSHS committee members have co-ordinated the implementation of all the government restrictions and will be directly involved in ensuring all aspects of the risk assessments are co-ordinated for a safe event. **ALL** helpers will be briefed on the rules and regulations and asked to sign a document to say they understand the risks and actions required. Copies will be handed to individuals

Risk Assessments, Health and Safety Policy documents have been forwarded to the Monmouthshire CC, ESAG Departments and Gwent Police, for advice and authorisation.

The key to ensuring a covid safe experience on show day is the organisation of the following actions.

1. **SANITISING STATIONS** at all entry points to the field, to trade stands, indoor areas, parade areas, and all toilets and seating areas.
2. **TRACK and TRACE** - ALL attendees - Exhibitors, Trade Stand Holders, Helpers and ALL members of the public **MUST** register their details as they enter the Park, (data will be kept for 21 days). Qualified Medical

Staff will be on site to monitor anyone with any symptoms of Covid 19, with sanitation measures taken immediately after.

3. **SOCIAL DISTANCING** – Entrance/exit areas to the park and areas on the field will be marked clearly as ONE WAY SYSTEMS. Regular reminders to ensure the rules are carried out will be announced over the PA system. Show Helpers (in Hi Viz Jackets) will be constantly monitoring “pinch points/busy areas “to manage the areas and avoid over-crowding. Also, in such area’s masks will be recommended.
4. **SOCIALLY DISTANCED CAR PARK, TRADE STANDS, and ATTRACTIONS**  
Cars will be parked 2m apart to ensure visitors can attend the show whilst maintaining the required social distancing. Trade Stands and Attractions will be positioned so they too can encourage social distancing.
5. **TRADE STANDS and INDOOR SPACES.** Marquees and Trade Stands, will be asked to reduce their indoor space by removing the sides of their stands/marquees as much as possible. Restrictions of public numbers in trade stands and indoor areas will be managed
6. **MASKS WORN INDOORS.** Masks must be worn at all times in indoor areas
7. **ONE WAY SYSTEMS** and **WIDENING OF AREAS** Ropes **AND** markers will be placed in indoor areas and “pinch points/busy areas” to encourage ALL visitors to social distance safely
8. **MONITOR AREAS.** Stewards will constantly monitor numbers of public in all areas to ensure social distancing. All Trade stands and attractions to be placed more widely apart across the site in order to comply with social distancing rules
9. **SANITIZING TOUCH POINTS.** ALL touch point areas will be treated with anti-viral treatment the day before and constantly sanitised throughout the day, especially toilet facilities and waste collection areas. Toilets will be managed to reduce any transmission of Covid 19 and volunteer helpers will ensure toilets are well ventilated and sanitised on a constant and regular basis.
